Date of Test: 20/10/14

Conditioning

The sample was conditioned to constant mass at a temperature of 23±2°C and a relative humidity of 50±10% and maintained in this condition until required for testing

Procedure

The test was carried out in accordance with BS 476: Part 7: 1987(1993). The sponsor sampled the material and the specimens were cut from the sample to the dimensions set out in the standard by FTS. The specimens were tested loose laid onto 12mm calcium silicate board

The following were recorded:-

- the time at which the flame front crosses each vertical reference line; a)
- the maximum extent of flame spread during the first 1.5 min from the start of the test; b)
- the maximum extent of flame spread during the whole test i.e. 10 min or less (if applicable) C)
- the time (and distance) at which maximum flame spread is reached. d)

The flame spread at 1.5min and the final flame spread results were compared with the standard class limits and a classification was assigned.

Requirements

The class limits for flamespread, detailed in BS 476:Part 7: are set out below.

A definitive classification is based on a sample of six specimens and the figure in brackets gives the tolerance by which only one specimen in six may exceed the class limit assigned.

Classification

The results indicate that the sample met the performance requirements of Class 1Y.

A suffix Y is added to the classification if any softening and/or any other behaviour that may affect the flame spread occurs. The Y suffix was added to this classification due to specimen softening and slumping within the holder after the initial first minute of testing.

An estimation of uncertainty of measurement has not been taken into account when making a judgement to any pass/fail criteria.
